UBS AG is the index provider.

The objective of the InsightShares Patriotic Employers ETF is to track the performance (before fees and expenses) of the Military Veterans Index™.

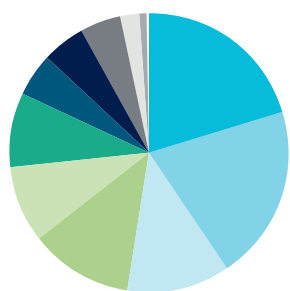

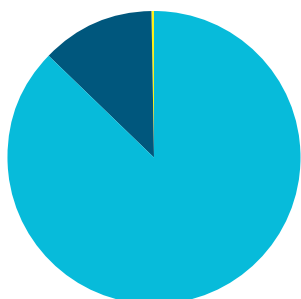
